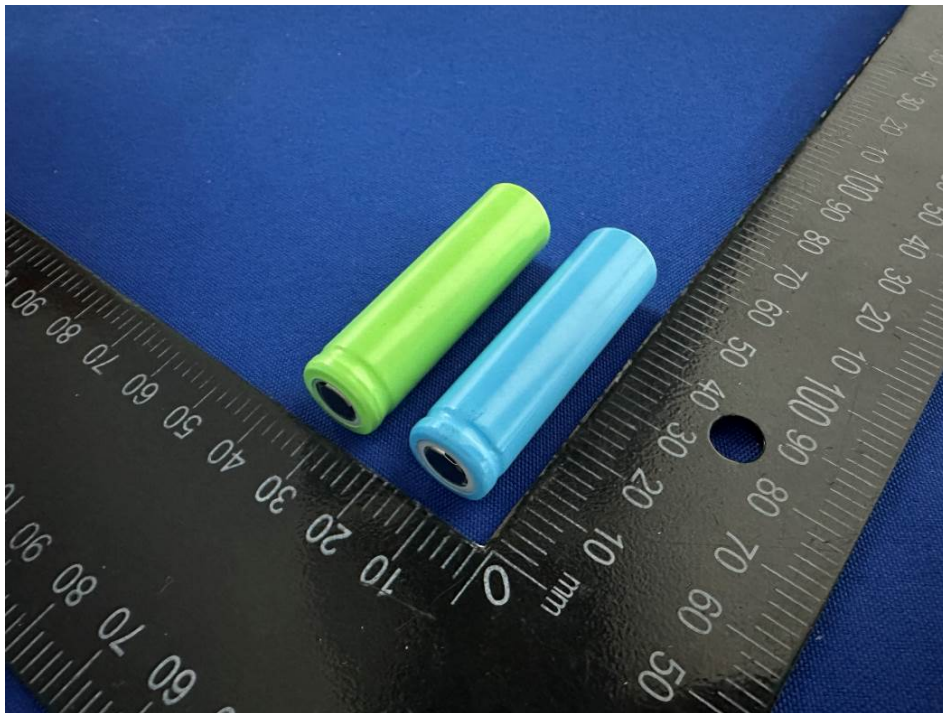

Picture 1. Side view-1 of cell for model HYLN IMR14500-300mAh



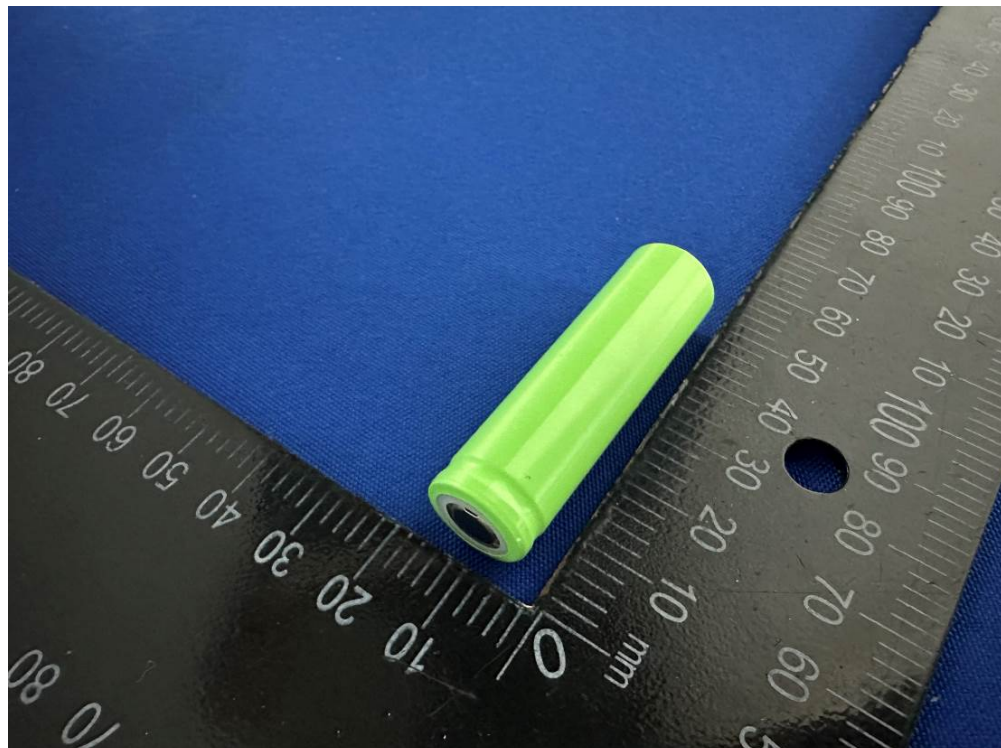
Picture 2. Side view-2 of cell for model HYLN IMR14500-300mAh

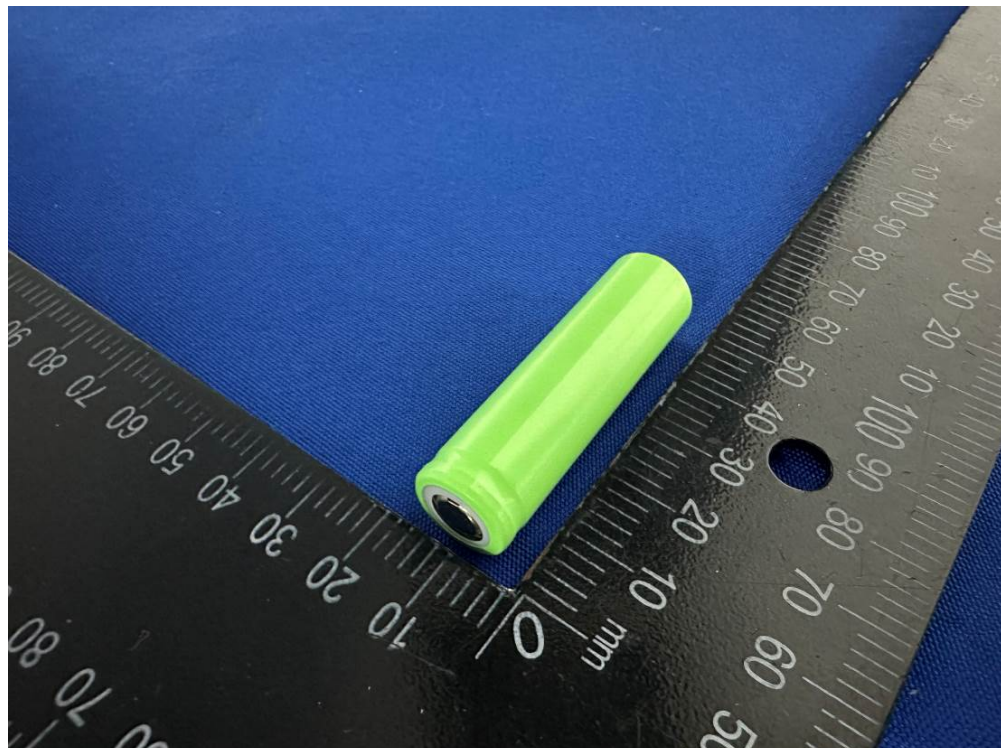
Picture 4. Side view-2 of cell for model HYLN IMR14500-400mAh

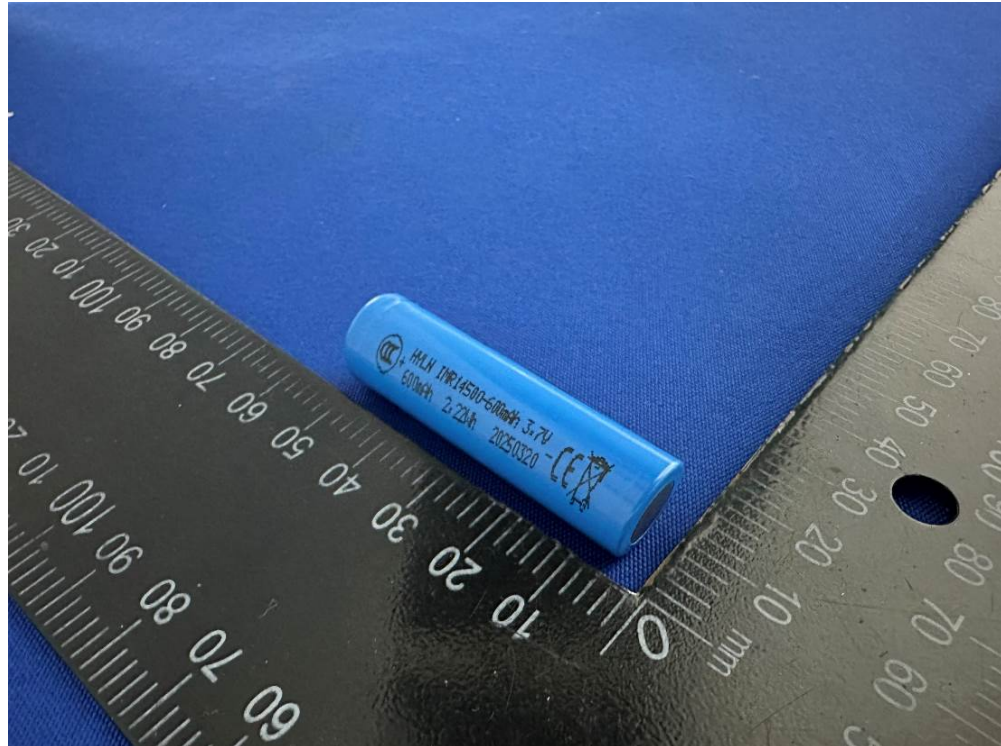
Picture 5. Side view-1 of cell for model HYLN IMR14500-500mAh



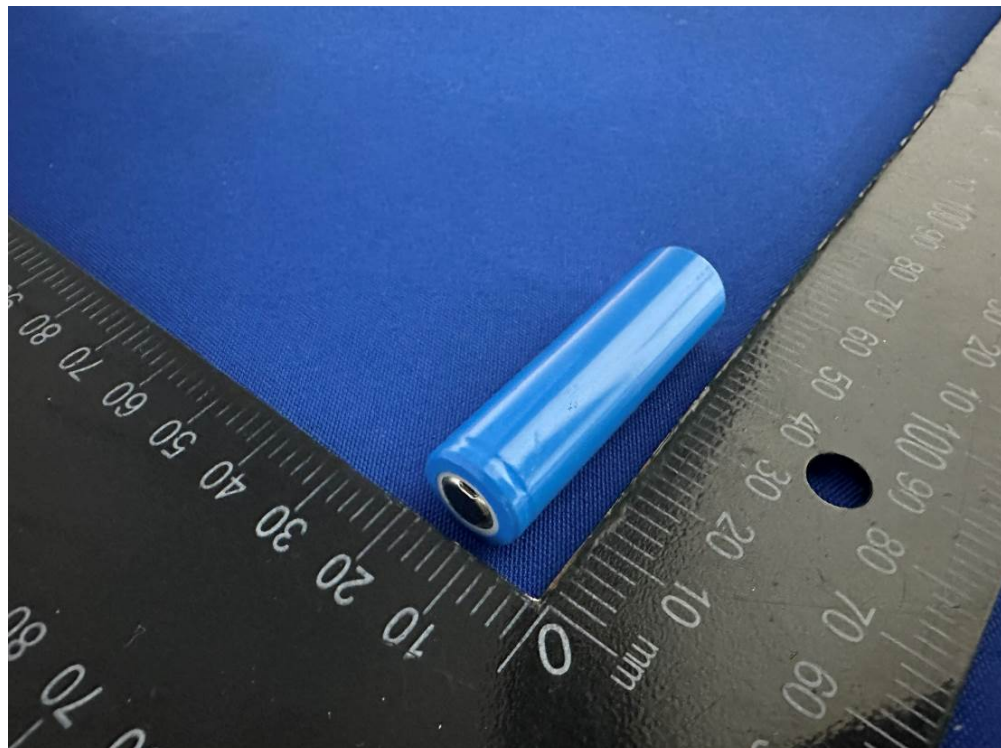
Picture 6. Side view-2 of cell for model HYLN IMR14500-500mAh

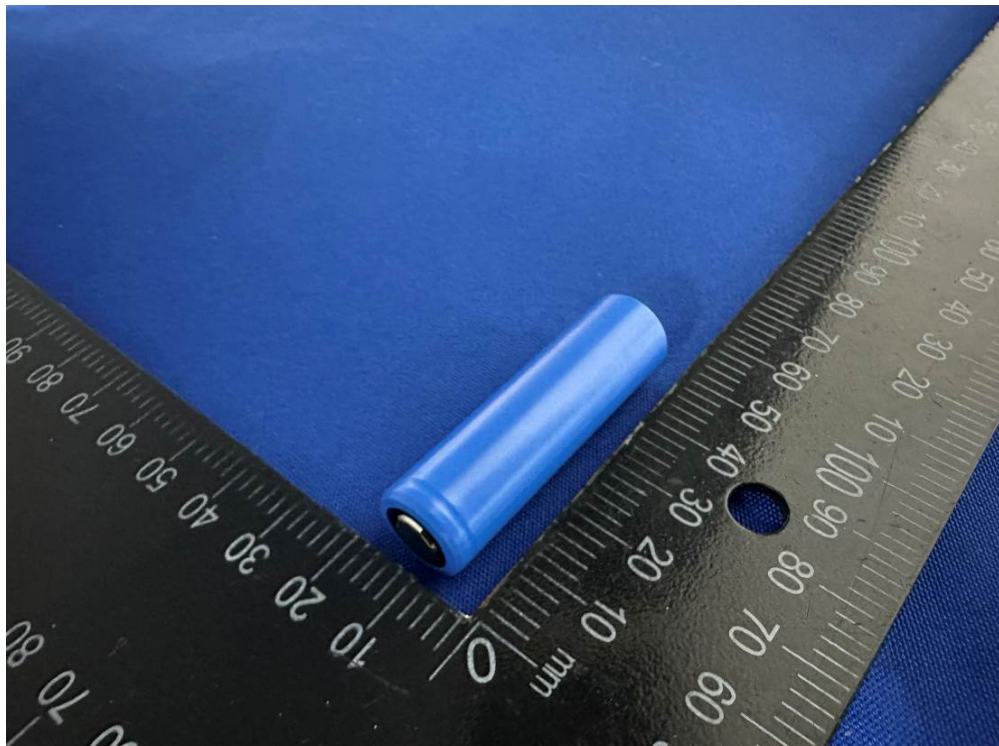
Picture 8. Side view-2 of cell for model HYLN IMR14500-600mAh
